Fee schedule rule affects EHR Incentive Program

A proposed rule released July 8 by the Centers for Medicare & Medicaid Services explains changes to physician quality programs for calendar year 2014. What's not immediately evident within the document is that it contains additional options for eligible professionals to report clinical quality measures.

CMS proposes complex care payment

Medicare only pays for primary care management services as part of a face-to-face visit. Under a proposed rule issued July 8, the Centers for Medicare & Medicaid Services would make a separate payment to physicians for managing select patients' care needs beginning in 2015.

Intervention helps improve and maintain better blood pressure control

An intervention that consisted of home blood pressure telemonitoring with pharmacist management resulted in improvements in BP control and decreases in BP during 12 months, compared with usual care, and improvement in BP that was maintained for 6 months following the intervention, according to a study in the July 3 issue of JAMA.
